

## 2025 Lawn Removal Program Information and Requirements

Thornton Water, in collaboration with <u>Resource Central</u>, is offering water customers discounted lawn removal services, including the physical removal of a selected portion of your lawn. The 2025 Lawn Replacement Program rate is just \$2.65 per square foot. Thornton Water will cover the first \$1.65 per square foot (up to \$750) and you'll only need to pay the remaining \$1.00 per square foot. As an approved participant, you can enjoy up to \$750 in discounts for lawn removal or a garden in a box kit.

This program aims to make it easier for water customers to save water outdoors and to help our community cultivate beautiful water-wise gardens. ## **Program Enrollment**

Applying for the program is simple. If you're interested in removing a portion of your lawn, just sign up here: <a href="https://resourcecentral.org/lawn/apply/">https://resourcecentral.org/lawn/apply/</a>.

Due to the high demand, we can only accept a limited number of participants. To secure your spot, we recommend the following:

- Submit early Resource Central will review and approve applications as they are received.
- Plan your project—Show us that you have a good plan for where you'll remove the grass, how you'll cover the space, and how you'll adjust your irrigation system and schedule. We need to see that your project will save water!
- ♦ Submit a complete application an incorrect water utility account number or missing "before" photo will slow down the approval process, and you may lose your space.
- ◆ After Resource Central reviews your application, they will guide you through a 15 30-minute phone consultation to review your project. Your application is not fully approved until you complete the consultation and return the signed contract.

It's important to note that Resource Central generally approves 90% of applications as long as they meet the basic project requirements and demonstrate significant water savings. Space and program funding is limited to a predetermined number of households. Supplies and participation are limited and fluctuate annually.

#### **Service Provided**

If your project qualifies, Resource Central will review your application and schedule a consultation. You are responsible for the \$1.00 per square foot lawn removal fee and purchasing, picking up and planting your Garden In A Box.

## **Qualifying Mulched Plant Beds for Your New Water-Wise Garden**

- 1. No more than 30 percent bare mulch (at plant mature size).
- 2. Eligible mulch types include shredded bark, bark chips, or rock.
- 3. Pick up plants at the location you choose on the Resource Central Garden In A Box pick-up days.
- 4. Plant your garden using the numbering system on the plant guide given to you with your new garden.
